The UWW Stormwater Management Plan is currently being updated by Strand Associates. Work on the updating was delayed do to new information anticipated from the WDNR on the TMDL (total maximum daily load) for the Rock River watershed and

consequently possible additional restrictions on permitted communities such as UWW and the City of Whitewater, other than the 40% TSS reduction requirement. This TMDL is the maximum amount of a pollutant a water body can handle and still function as it is intended to do so. This Stormwater Management Plan will not be completed before the March 31, 2011 report date.

As indicated above, this plan is currently being updated.
