

Universities of Wisconsin employees that have retired or will retire within the next few months have an opportunity to enroll in or make changes to their benefits for the 2025 plan year **during the Annual Benefits Enrollment (ABE) period, September 30 - October 25, 2024.**

For active employees considering retirement, your current health insurance coverage will automatically continue into retirement. Retirement is **not** an opportunity for you to change your health insurance carrier or plan design (other than to an ETF Medicare plan).

The below resources are available to help already retired or upcoming retirees with their benefits decisions for the 2025 plan year. Note: To enroll or make changes to your benefits for the 2025 plan year, you must submit your changes **during the Annual Benefits Enrollment (ABE) period, September 30 - October 25, 2024.**

- If you have already retired, you must submit your health insurance changes to the Department of Employee Trust Funds (ETF) and your dental/vision insurance changes to Delta Dental of Wisconsin during ABE.
- If you are still an active employee during ABE, you must make your changes to your benefits for 2025 through the MyWisconsin portal at my.wisconsin.edu. Review the ABE web page (<https://www.wisconsin.edu/abe/>) for more information.
