

During the Annual Benefits Enrollment (ABE) period, **September 27 – October 22, 2021**, employees who retired/will retire from the UW System on or before December 31, 2021 have an opportunity to enroll in or make changes to their insurance plans. Several resources are available to help **retirees** during the ABE period.
