# **Keynote**

Ju'Riese Colón is the Chief Executive Officer of the U.S. Center for SafeSport, the nation's only nonprofit organization committed to ending all forms of abuse in sport. As CEO, Ju'Riese leads the strategic vision and direction of the organization to ensure every athlete is safe, supported, and strengthened throughout the Olympic & Paralympic Movement. Ju'Riese previously served as the National Vice President of Child & Club Safety for the Boys & Girls Clubs of America. She was responsible for developing and leading the organization's child safety policies and initiatives for more than 1,100 Boys & Girls Club Organizations and 4,300 Boys & Girls Club locations across the United States, including those located on Native lands and military bases. Ju'Riese also served as the Executive Director of Prevention & Outreach for the National Center for Missing & Exploited Children (NCMEC). She led NCMEC's prevention and education programs, and initiatives related to online safety, child abduction and sexual exploitation and their delivery to children, families, schools, and the public. Ju'Riese was with NCMEC for 15 years. Her professional experience also includes leading prevention and outreach initiatives with youth serving organizations serving families, educators, law enforcement, and diverse communities. Ju'Riese is an experienced child advocate and serves as an expert on issues related to child safety. Ju'Riese is a member of the American Camp Association Board of Directors and serves as chair of the ACA Board Diversity Committee. She is a graduate of Virginia Commonwealth University where she received degrees in both Criminal Justice and Spanish. Ju'Riese is based in Denver, CO.

#### **Brenda Yang**

Brenda is originally from Northern California but has lived in Sun Prairie for 22+ years. She is a first-generation Hmong immigrant born in Laos who survived war and genocide. Her parents fled the Viet-Cong and found refuge in Thailand and with sponsorship from churches, she immigrated to the states as a young child. She studies cultural identity and its significance in public schools and works full time as the Upward Bound Advisor/Director in advocating for High School students that come from low-income and first-generation backgrounds and helps them gain access to higher education. In addition to being an educator, she works as a consultant for the City of Madison Dept. of Civil Rights helping to promote language access for SE-Asian Families. She also serves on the Dane County Board of Supervisors as a Supervisor for District 19. In addition to this, she works with community leaders on issues affecting the Hmong and SE-Asian Community in regard to education in public schools and serves on the board for the YWCA of Madison in helping to promote equity, access, and empowerment for communities and families in Dane County. She is passionate about: social justice, economic justice, educational justice, policy-reform, and finding sustainable solutions.



#### Nichelle Nichols

Nichelle Nichols joined National Equity Project in July, 2021. She previously worked at the Madison Metropolitan School District in Madison, WI as the Executive Director of the Office of Equity & Engagement where she led the charge on the district's Black Excellence strategic priority, advanced racial equity efforts and implemented strategies on family engagement, community partnership, youth voice and Community Schools. Ms. Nichols worked at the Madison school district since 2015. Her career has spanned over 20 years in the non-profit and public sector serving the greater Madison, WI area including serving as the Chief Academic Officer at the Boys and Girls Club of Dane County; Vice President of Education at the Urban League of Greater Madison; Volunteer Manager at Big Brothers Big Sisters and Development Director at Community Action Coalition. Ford provides institutional level strategic student outreach, academic support, and engagement initiatives to support student access and success, promote diversity and equity, and foster a supportive, inclusive environment. Over the past eighteen years, Ford has worked in non-profits and post-secondary institutions to advocate for systematic changes to better align K-12 education programming with college-ready expectations. In 2017 Ford was named by BRAVA Magazine a Woman 2 Watch for her exceptional work in college access. Ford received her Master's of Science in Adult Education from the University of Wisconsin-Platteville and her Bachelor's Degree in Applied Speech Communication from Ferris State University.

# **Dr Michael Ambrose**

**Michael Ambrose**, founder and director of DocNetwork, earned his M.D. from the University of Michigan Medical School, completed a Pediatrics residency at the University of Michigan's C.S. Mott Children's Hospital, and is a board-certified pediatrician.

While in medical school, Michael drew from his experience as a longtime summer camp participant and camp staff member, as well as his growing knowledge of pediatrics, to develop software that would improve efficiency and maximize safety at camp. Michael launched CampDoc in 2009 to reach camps across the country facing challenges with pen-and-paper systems to track camper and staff healthcare needs. In 2013. Michael launched ChildCareDoc and SchoolDoc. Michael is an active member of the American Academy of Pediatrics and has published and presented studies on camp and school health at conferences for the American Academy of Pediatrics, the World Association for Disaster and Emergency Medicine, the Society of Academic Emergency Medicine, and Pediatric Academic Societies. Michael has been involved in camp and school health for over 15 years and remains devoted to creating innovative solutions for camps and schools. At DocNetwork, Michael works with key industry partners and ensures that business strategy aligns with the company vision.

Prenicia Clifton joined the Office of Compliance & Integrity in September 2020. Prenicia is a native of Kansas City, Missouri and a graduate of the University of Wisconsin-Madison. She has nearly 2 decades of precollege and youth programming experience under her belt. Prenicia has always had a love for camp and enriching the lives of youth. At the age of 21 Prenicia made a pledge to make a difference in the lives of 10,000 kids. She achieved this goal quite easily through programming and fundraising and has now changed that goal to a million. So how does one affect the lives of 1 million children? Well, believes that this can be done at the policy and access level which led her to become a youth protection specialist and advocate.

Prenicia is a certified Praesidium Youth Protection Guardian and trained in youth behavior/assessments and Youth Mental Health First Aid. Her experiences in program development abroad have given her strengths in youth protection, program development and implementation, as well as best practices for addressing youth protection polices at the institutional level. Currently Prenicia is a member of the Higher Education Prevention Network serving on the membership committee as well a chair on the Big Ten Youth Policy Consortium. One of her major initiatives within the Big Ten Policy Consortium is "The Architecture of Compliance within Youth Programming in Higher Ed" a research document based on youth programming nationwide standards, historical gaps, and the translation of typical "camp" scenarios and vocabulary into higher education open campus settings.
