## Direct Admissions Task Force: Background and Context

At the August 18, 2022 Education Committee meeting, Regent Chair Kyle Weatherly asked UW-Parkside Provost Rob Ducoffe to facilitate an initial conversation exploring the idea of direct admissions, which "side steps the typical admissions process by proactively and automatically admitting students to college based on a data match between K-12 schools and postsecondary institutions." The Committee discussion included academic experts, Professors Jennifer Delaney and Taylor Odle, and UW campus professionals and chancellors about the merits of direct admissions within the UW System. Presenters and speakers considered the potential benefits, implementation challenges, and lessons learned from other states and universities.

Before the meeting, Regent Weatherly had introduced the idea to Provosts, Chancellors, Student Affairs Officers, and other constituent groups as a strategy to increase college access and enrollment, especially from historically underrepresented groups. Several states including Idaho, Hawaii, and Minnesota have experimented with direct admissions programs. These optin pilot programs have been established both at individual universities and on systemwide levels.

Typically, in direct admissions programs, "all students are admitted to all open-access and non-selective institutions, while students who surpass a pre-identified threshold based on high school performance (such as GPA, standardized test scores, class rank, or a combination of measures) are also admitted to selective institutions. Students, parents, and high schools receive letters indicating a student has been admitted to a set of institutions that also outlines

steps for how students can 'claim their place' using a common and free application. Programs can provide both tailored information for students and families about college and provides the guarantee of a place at a set of postsecondary institutions in the state." Direct admissions programs intend to simplify the application process by leveraging existing student data. They can provide agency for students in the process, and allow admissions counselors to "have more time to spend on outreach, on financial aid packages and on helping students rather than evaluating them." Preliminary results from Idaho have shown 8-15% enrollment growth from in-state students.

# Task Force Charge and Objectives

- Complete Regent Weatherly's charge to AVP Johannes Britz.
- Develop a representative and inclusive task force.
- Develop a communication plan that will gather feedback from the campuses and allow the task force to report out to various stakeholders groups in a timely manner.
- Understand the current enrollment landscape across the system through current enrollment data and identify additional data needs.
- Define options for what direct admissions could look like within the UW System.
- Explore and understand the impact a direct admissions program would have on current policy and practice, and identify processes and estimated timelines for addressing any changes that would need to occur.
- Identify the resources needed to implement a direct admissions program, inclusive of system-wide resources, campuses resources and external stakeholder resources.
- Explore barriers or threats to implementing a direct admissions program.
- Provide potential solutions for any identified barriers or threats.

# Task Force Membership and Duration

The task force membership consists of broad representation from UW System campuses, UW System Administration and the Wisconsin Department of Public Instruction. Task Force members commit to meeting twice per month starting October 2022 until early Spring 2023.
