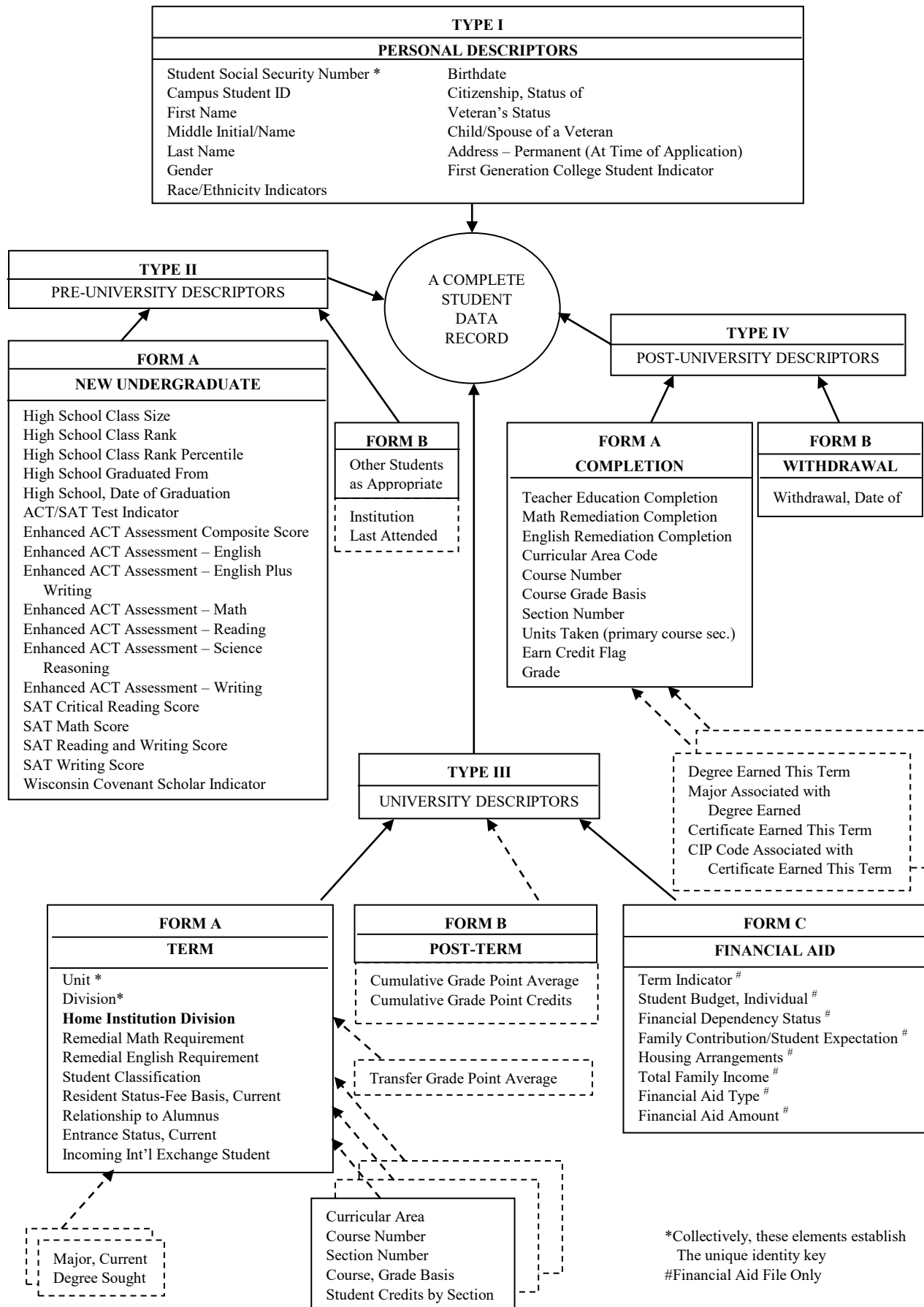
STUDENT DATA AREA

Overview

The Student Data Area identifies and describes elements of data which pertain to students within the University of Wisconsin System. In order to more easily conceptualize these data, they have been somewhat artificially grouped into four primary types, i.e., Types I, II, III and IV. Page II.C.2 illustrates these groupings with dotted lines referring to elements which are not always required for logical record completion (solid lines referring to elements which are always required), and recurring blocks depicting elements for which multiple occurrence is possible. Neither the diagram nor the logical listing of data elements is to be construed to imply a physical record layout; rather, a logical structure is being described.

Each complete record identifies and describes a unique student. Uniqueness is established by a single combination of two data elements: one within the Type III descriptors, i.e., Unit (includes Division for UW Colleges) and one within the Type I descriptors, i.e., Student Social Security Number. These two elements are referred to as the entity key. Whenever either of these descriptors changes, another unique student is identified.

The data elements are grouped into four types on the basis of their relationship to an educational institution. Not all elements in each type are required for the completion of each student's term-record. Type I (referred to as Personal) descriptors are educationally (or institutionally) independent. Further, it seems reasonable to assume that exactly one set of these (Type I) elements is required for the completion of each student's term-record. The Type II (Pre-University) descriptors are divided into two forms (Form A and Form B) and, in both cases, contain information about the educational institution previously attended by the student. Neither Form A (pertinent to new undergraduates) nor Form B (pertinent to other students as appropriate) would always be relevant to each student's term-record. The Type III (University) descriptors are also divided into two forms (Form A and Form B), both of which contain student information which is directly related to his (her) current university experience; Form A containing information of relevance at the beginning of the term, and Form B containing information of relevance at the end of the term. Finally, the Type IV (Post-University) descriptors name certain variables which have meaning when a student completes a university experience, by obtaining a degree or certificate.

MULTIPLE APPLICATIONS AND ADMISSIONS DATA (MAAD)

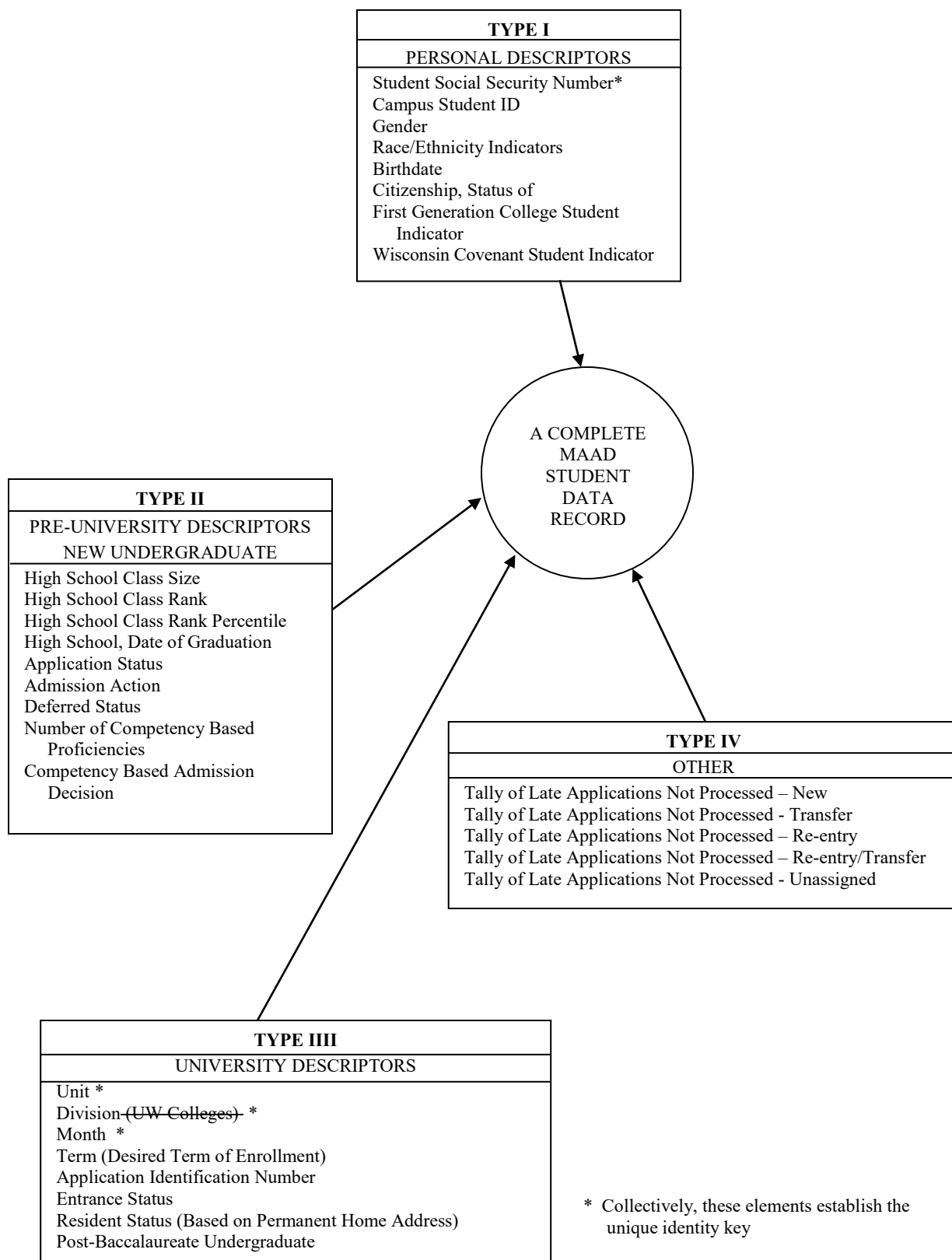
Overview

Multiple Applications and Admissions Data (MAAD) includes data that identify and describe students who have applied for undergraduate enrollment at one of the University of Wisconsin System institutions. It records data, on a monthly basis, about the applicants and the admission action taken on each application.

The monthly MAAD submissions are cumulative from the time an application for the reporting year/term is initially recorded until the final MAAD submission of the cycle. Thus, records of applicants who withdraw or cancel their application remain on each MAAD submission for the cycle. The monthly MAAD submissions should include records for all new, transfer, and re-entry degree-seeking undergraduate applicants who are applying for the upcoming summer or fall terms. The cycle culminates with the “end of cycle” submission in September. In addition, there is a single “end of cycle” March submission for spring and winter term applicants.

Each MAAD record identifies and describes a unique student application. Uniqueness is established by a combination of data elements: Student Social Security Number, Unit (and Division for UW Colleges), Desired Term of Enrollment, and the reporting Month. These elements comprise the entity key.

MAAD data can be grouped into four types as illustrated in the diagram on the following page. Many of the MAAD elements are the same or similar to those collected in the CDR Student Data area. Type I (Personal) descriptors provide basic identifying and demographic information about the applicant. The Type II (Pre-University) descriptors contain information about the educational institution previously attended by the student and information related to the student’s application and admission status. Type III (University) descriptors include student information specific to the desired UW campus and term of enrollment. Type IV (Other) provides information on late applications that were received after admissions were closed and for which individual applicant records were not submitted.

The edits are listed in sequence by Error Number which is either the number of the data element being edited, or is a fabricated number which represents the edit of a group of data elements in combination.

When a group of data elements must be edited together, i.e., a combination edit, the Error Number has been developed on the basis of the following coding scheme; each position of the Error Number identifies a significant aspect of the combination edit.

Position 1: contains a code identifying the data area to which the element belongs; the valid codes are as follows:

1 = Curricular data area

2 = Student data area or Financial Aid data area

5 = Multiple Applications and Admissions Data (MAAD)

Position 2: contains a '9' to identify the Error Number as a combination edit.

Position 3: contains a code identifying the submission cycle which the edit addresses; the valid codes are as follows:

8 or 9 = sixth-week submission cycle

P = post-term submission cycle

A = annual submission cycle

Position 4: contains a number which uniquely identifies the combination edit in sequential order within the edit set defined by Positions 1 through 3.

Thus, Error Number 2981 identified the first combination edit of the student sixth-week submission cycle. The individual data elements included in each combination edit are listed in the sequence which is required for the edit.

Edit Type (Y)

The Edit Type code identifies the type of relationship considered in each edit. The following codes are used:

- 1 = Intra-element; an edit of a single element with no reference to the element's relationship with any other element(s).
- 2 = Inter-element; an edit of the relationship(s) between an element and any other elements within the same data area.
- 3 = Inter-file; an edit of the relationship(s) between the files of a single submission cycle (e.g., sixth-week student and sixth-week curricular).
- 4 = Inter-submission cycle; an edit of the relationship(s) between the files of a single data area (e.g., sixth week student and post-term student).
- 5 = Inter-period; an edit of the relationship(s) between the files of a single data area but over different submission periods (e.g., student's entrance status for summer and fall semesters).
- 7 = Inter-record; an edit of the same element(s) between records of a single file and single submission cycle (e.g., the same element across all sections of a course on the sixth-week curricular file).

Edit Degree (Z)

The Edit Degree code indicates the severity of the error identified by the edit. The following codes are possible

- 1 = An error which must be corrected. In all cases, the invalid data is left on the file.
- 2 = A reasonability exception which may be an error; correction is necessary if it is determined to be an error

Examples:

- a. 2020-11: The data code of Gender (DE 2020) in the student data area is in error. The invalid data remains until the data element is corrected.
- b. 2170-21: The division (DE 2170) in the Student data area is in error in relation to unit (DE 2160). Either or both of these codes might be invalid.
- c. 2981-41: The elements included in this combination edit of the sixth-week student submission do not match the post-term student submission.
- d. 2340-22: The total credits carried by the student are greater than the reasonability limits. This may or may not be an error.

Exceptions

Edits associated with post-term student course section enrollments are indicated as XXXXpYZ, where XXXX, Y, and Z, remain the same as the equivalent edit on the sixth-week submission and the "p" indicates that the edit applies to the post-term student course section record.
