Re: 2022-23 CDR Manual Update

As you review the update document, modifications to the CDR documentation are primarily noted in the right margin. These are marked by '+' for additions, '-' for deletions, and 'x' for changes.

Please review the following items and respond to Jennifer White (jwhite@uwsa.edu) with any updates, corrections, or concerns by August 3, 2022:

- CDR Curricular Area Code (CAC) Table (Volume II, Table I.C) Check with your Budget Office and Registrar's Office to ensure that your institution's CAC/UDDS crosswalk table reflects current budget and curricular (subject) areas. Please inform us of any changes for the 2022-23 academic year. Changes already submitted for 2022-23 will be reflected in the August update (and currently available in the Oracle table).
- CDR submission due dates (Volume I, Pages III.A.3-6). Please make note of these due dates and share as needed.
- Section Length (DE 1130) Confirm the number of weeks for fall and spring 2022-23 semesters are accurate. Please contact us if changes are needed. Note that the final exam period is included in the term length.
