Overview

12-month Enrollment Overview

The 12-month Enrollment component collects unduplicated student enrollment counts and instructional activity data for an entire 12-month period. Using the instructional activity data reported, a full-time equivalent (FTE) student enrollment at the undergraduate and graduate level is estimated. Institutions with Doctor's - professional practice students will also report the FTE enrollment of those students. NCES uses the FTE enrollment to produce indicators such as expenses by function per FTE as reported in the IPEDS Data Feedback Report.

The increase in enrollment comes from the much larger B.S. Business Administration degree program.

Reason:	Due to restructuring of UW System institutions, UW-Parkside took over the Flex BS Business Admin degree from UW Extension's Division of Continuing Education, Outreach, and E-Learning. This explains the far greater credit hour activity from 7/1/18-6/30/19 compared to the previous year (7/1/17-6/30/18). Further, because Flex is geared toward working adults, our population is all part-time students. Our divisor for institution-reported FTE, based on student behavior, is set at 18.
