Academic Libraries Overview

Reason	ILL position was hired during FY20; services were in flux during training. Additionally, over the last several years the library's physical collection has been weeded extensively; library has fewer physical items to lend. The UW system resource sharing program was halted for several months during COVID pandemic; building was also closed for periods.
