#### Academic Libraries Overview

Reason	The library saw a large increase because of the use of the RAPID ILL service. Also, the ILL department was fully staffed for the entire year, including student help. In the previous year, FY2022, our ILL department was not fully staffed as we had our ILL Coordinator resign.			
Screen Entry	The number entered (1,755) is outside the expected range of between 1,764 and 3,276 compared to the prior year value. Please correct your data or explain. (Error #15015)	Explanation	Yes	
Reason	The large discrepancy from FY2022 to FY2023 was due to an inaccurate count from last year (FY2022). In FY2022 we double-counted our Rapid ILL transactions in the overall numbers. FY2022 number should be 1,828. So FY2023's number should only show a slight decline from FY2022.
