Overview

#### **Admissions Overview**

Welcome to the IPEDS Admissions (ADM) survey component. The primary purpose of ADM is to collect basic information about the undergraduate selection process for entering first-time, degree/certificate-seeking students in the fall term. This includes information about admissions considerations, admissions yields, and SAT and ACT test scores (if test scores are used in admissions decisions). The vast lion's share of our student population are older (average age = 35), work full-time, and have families. As such, first-time students are a rarity. Most of our students already have some college or even prior associates or bachelor's degrees. Several of our programs, however, do not bar first-time students from applying and enrolling. Because the numbers of first-time students are typically always very low (there are only 6 in this cohort), our admissions yield can easily go over 80% - we admitted and 6 enrolled.
