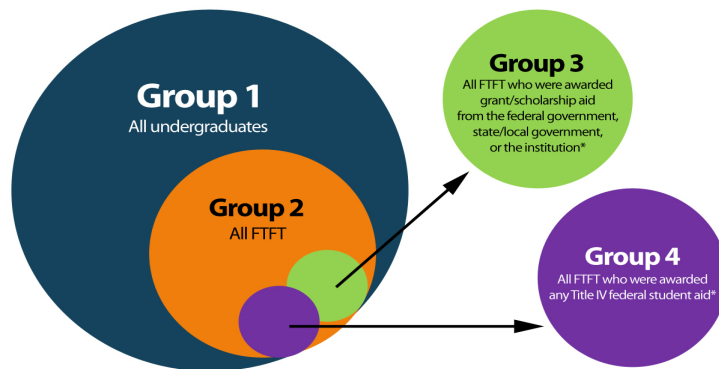
### Overview
