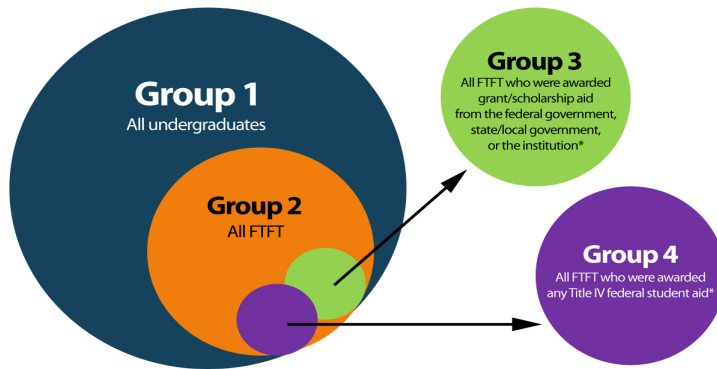
Overview
