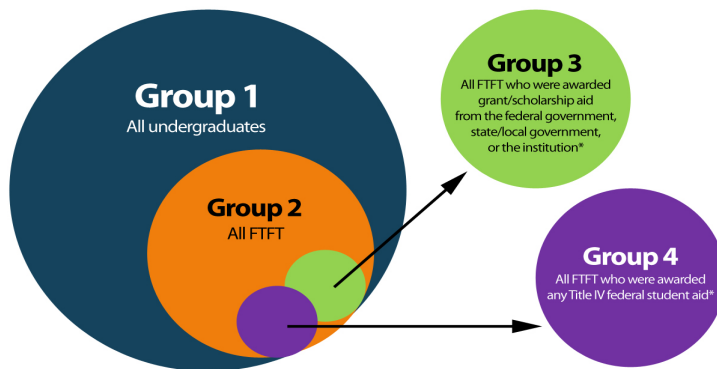
Overview
