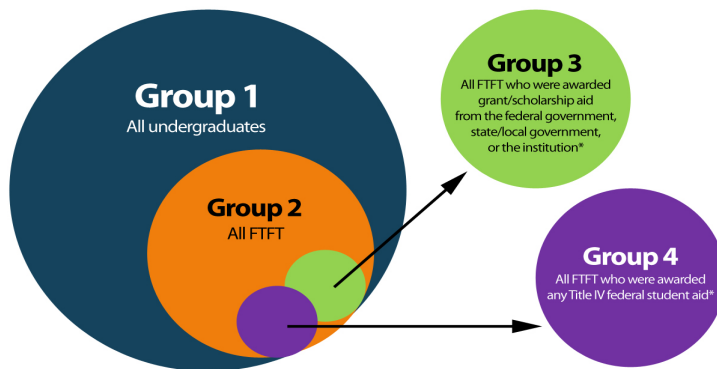
### Overview
