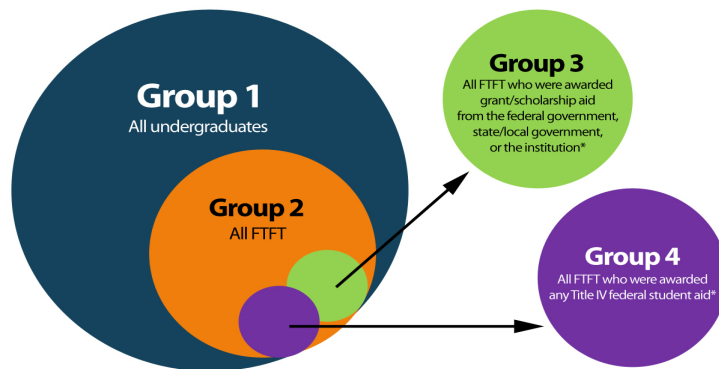
Overview
