PROFESSIONAL EXPERIENCE

President University of Alaska

The University of Alaska is established in the Alaska Constitution as the state's sole system of higher education. UA is a world leader in Arctic research, one of the nation's most affordable systems of higher education, and provider of over 92% of Alaska's higher education. As president and chief executive officer of the Board of Regents, I oversee three universities and thirteen community colleges, with an annual operating budget of ~\$900 million, 7,000 faculty and staff serving nearly 30,000 students in over 400 programs (on campus and on-line) granting awards ranging from occupational certificates to doctoral degrees. I advocate for higher education before a wide variety of audiences including Alaska's federal delegation, Governor, legislators, state and federal agencies, media, employers, Alaska Native and tribal organizations, and community groups across the state.

- Developed and led the Strategic Pathways process, refocusing the university system on meeting the state's higher education needs during multi-year funding reductions; cut deeper to invest in the Board's 2025 strategic goals: economic development, research excellence, workforce development, educational attainment, and cost effectiveness.
- Maintained global preeminence in Arctic research, expanded dual enrollment programs with K-12, increased on-line program offerings and degree completion programs, completed new engineering facilities, improved intercampus collaboration, and strengthened outreach to major employers.
- In collaboration with the Board of Regents and campus leaders, formulated and led the university's strategic visioning, planning and budgeting process, resulting in long term vision (Alaska.edu/UA2040), goals and performance measures (to 2025), programmatic priorities, and implementation plans.
- Led the university's proactive disclosure and system wide response to federal Title IX review, emphasizing compliance and a culture of safety for students, faculty, and staff.
- In response to 41 percent state funding cut in 2019, engaged university leaders in preparation of contingency plans involving more cost effective administrative services, academic program consolidation and reduction, and financial exigency.
- Successfully negotiated a Compact Agreement with the Governor, which reduced the cut from 41 percent in one year to 21 percent over three years.
