**COUNT 1: MISCONDUCT IN PUBLIC OFFICE BY ACT IN EXCESS OF  
LAWFUL AUTHORITY** (illegal loan guarantee for Oshkosh Premier Waterfront Hotel and Convention Center). On or about the time period of June 21, 2012, to present, in the city of Oshkosh, Winnebago County, Wisconsin, in his capacity as a public employee, committed acts which he knew were in excess of his lawful authority, as a party to the crime contrary to Wis. Stat. § 946.12(2), 939.50(3)(i), and 939.05.

**COUNT 2: MISCONDUCT IN PUBLIC OFFICE BY ACT IN EXCESS OF  
LAWFUL AUTHORITY** (illegal loan guarantee for Rosendale Biodigester). On or about the time period of June 21, 2012, to present in the city of Oshkosh, Winnebago County, Wisconsin, in his capacity as a public employee, committed acts which he knew were in excess of his lawful authority, as a party to the crime contrary to Wis. Stat. § 946.12(2), 939.50(3)(i), and 939.05.

**COUNT 3: MISCONDUCT IN PUBLIC OFFICE BY ACT IN EXCESS OF  
LAWFUL AUTHORITY** (illegal loan guarantee for Witzel Biodigester). On or about

September 22, 2010, to present in the city of Oshkosh, Winnebago County, Wisconsin, in his capacity as a public employee, committed acts which he knew were in excess of his lawful authority, as a party to the crime contrary to Wis. Stat. § 946.12(2), 939.50(3)(i), and 939.05.


**COUNT 4: MISCONDUCT IN PUBLIC OFFICE BY ACT IN EXCESS OF LAWFUL AUTHORITY** (illegal loan guarantee for Alumni Welcome and Conference Center).

On or about June 21, 2012, to present, in the city of Oshkosh, Winnebago County, Wisconsin, in his capacity as a public employee, committed acts which he knew were in excess of his lawful authority, as a party to the crime contrary to Wis. Stat. § 946.12(2), 939.50(3)(i), and 939.05.

**COUNT 5: MISCONDUCT IN PUBLIC OFFICE BY ACT IN EXCESS OF LAWFUL AUTHORITY** (illegal loan guarantee for Oshkosh Sports Complex). On or about June 21, 2012, to present, in the city of Oshkosh, Winnebago County, Wisconsin, in his capacity as a public employee, committed an act which he knew was in excess of his lawful authority, as a party to the crime contrary to Wis. Stat. § 946.12(2), 939.50(3)(i), and 939.05.
