

New Initiative Funding vs. Lapses/Cuts


(GPR/Fees in biennial dollar increases in millions)

Other Agencies

- Funding for WHEG
 - Increases to \$50 m. in 2007-08
 - Increases to \$55 m. in 2008-09

- Funding for Veteran's Remission
 - Provides \$5,013,700 in 2007-08
 - Increases to \$6,562,300 in 2008-09



Statutory Language

- Increases Application Fee
 - \$9 for Undergraduates
 - \$11 for Graduates

- The Board is required to:
 - Allocate \$200,000 for School of Public Health in Milwaukee if approved by the Board
 - Allocate \$25,000 for Short Course for Chinese Students



Statutory Language

- The Board is required to:
 - Provide Various Reports on IT Projects
 - Provide Segregated Fee Information on Website
 - Provide annual reports on limited, concurrent, and back-up appointments.



Statutory Language

 Waiting period for health insurance for new employees reduced from 6 to 2 months
