By the Numbers

- Federal estimates are that one in 4 women will be raped in their lifetime
- One in 13 Wisconsin women report being raped to law enforcement
- One in 20 women on Wisconsin campuses report being raped to law enforcement

By the Numbers (cont.)

- 96,528 women age 15-24 in the state
- 23,597 women enrolled on campus
- Epidemic

FORWARD Wisconsin

Statewide Sexual Violence Prevention Plan seeks to provide systems infrastructure to encourage and support a range of activities to change current environments that support sexual violence.

Guidance Document

- Wisconsin Coalition Against Sexual Assault and UW System to collaborate on the development
- Clarify roles and responsibilities
- Clarify challenges
- Outline collaborative practices

Campus

"Faculty, staff, administrators, and students must play key roles in the creation of a campus culture that reflects civility, honor, respect, and nonviolence."

Comprehensive Training

- Recognize behaviors
- Immediate response
- Disclosure response
- Services and consequences
- Violence as a determinant of health and academic success.

Reporting

- UW System Administration annually solicits and aggregates institutional reports
- The culminating UW System Report on Sexual Assault and Sexual Harassment is shared with BOR and the legislature
- The statistical report is forwarded to the Office of Justice Assistance

Data and Narrative

- All assaults reported to University officials
- Includes 5 geographic locations
- Institutional narratives detail methods of compliance with 36.11(22), as well current sexual assault prevention/awareness initiatives



Addressing Sexual Assault




Prevention Education

Before violence happens


Victim Services

Address victim safety, emotional, physical, and/or legal needs



Perpetrator Accountability

Perpetrating violence has consequences



Sexual Assault on a UW Campus

- Prevention of perpetration; support for victims
- Intersection of dating violence and stalking
 - Serial rapists using stalking
 - 60% of campus assaults by dating partner

Sexual Assault on a UW Campus (cont.)

- Women experience more SA/DV victimization between the ages of 16-24 than at any other time
- College SA victims have low rates of reporting to law enforcement (1 in 20)

Prevention—What We Know

Common first year student misconceptions:

- that force has to be used in sexual assault
- that it has to be a stranger or it's not rape
- cannot define sexual assault
- what constitutes consent
- if both are drinking, no one is responsible

Alcohol as primary "date rape" drug

Survey of 2,100 UW-Madison Students (2009)


- 94% said you can get consent from someone who has been drinking
- Students do not equate drinking with being intoxicated
- 83% indicated you *can* tell when someone is too intoxicated to give consent; what about the other 17%?

What are we doing?

- Training law enforcement officers and judicial officers to hold perpetrators accountable
- First Year Education/Orientation
- Service learning courses
- Social marketing
- Increasing likelihood victims will seek and receive help







/e-voke/ –verb, e-voked, e-vok-ing: to elicit or draw forth: to call up; cause to appear; summon

- Magnets and wallet cards
- Rape Crisis Center
- DV shelter
- Police

Recent Media Coverage

- News stories about how schools are 'covering up' knowledge of assaults
 - Make policies accessible and understandable by students, faculty, staff
 - Expand prevention efforts to incorporate perpetrator accountability
 - More reports do not stop rape
 - Victims are entitled to their experiences

What do campuses need?

- Clear guidance to address the nexus between UW system/state and federal reporting requirements
- Changing perceptions: stranger assaults and alcohol facilitated sexual assault
- Collaborating with communities and sexual assault service providers
