

# 2012-13 Annual Budget

### FY 2012-13 Annual Budget

- Primary budget source the 2011-13 biennial budget approved by the Legislature and the Governor
- Chapter 20 of the biennial budget act includes most of the state dollars and tuition authority for the University of Wisconsin System

#### Segregated Fees by Campus

- ✓ Segregated Fees range from \$859 at UW-Whitewater to \$1,363 at UW-Superior and average \$1,065.
- ✓ Increases range from \$-4 to \$83 at UW-Milwaukee.
- √ The major reasons for increases are:
  - ✓ Funding for major projects and student approved facility enhancements.
  - ✓ Student initiated programming.
  - ✓ Additional staffing, supplies and expense.

#### Room & Board Rates by Campus

- ➤ Room and Board costs range from \$5,610 at UW-Superior to \$8,594 at UW-Milwaukee, with an average of \$6,415
- ➤ Increases range from \$70 to \$412. The average increase is \$231 (3.7%)
- > The major reasons for increases are:
  - ✓ New and renovated residence halls
  - ✓ Facility maintenance projects
  - ✓ New meal plans and extended service hours

### Why Tuition Increases are Needed

- √\$34 million partial restoration of base to maintain capacity for Growth Agenda for Wisconsin
- ✓ Continue key instructional and support services
- ✓ Limit impact on access and quality:
  - Class size increases
  - # of faculty teaching
  - # of classes offered

#### **Tuition Peers**

- <u>UW-Madison</u>\* among the lowest tuition of Big 10 peers after increases, and the dollar gap has remained at about \$1,330 the last two years
- Madison, Milwaukee and Comprehensives all remain below 2011-12 peer average after the 2012-13 proposed increases.

## Improving Affordability

- Increasing the number of WHEG Awards.
- Tuition Assistance Grants for middle income students.
- Covenant students will receive state and foundation grants.
- Lower cost access for students at Colleges (14,000+)
- Madison and Eau Claire differentials include financial aid.
- Increases in private institutional aid.
- Initiatives to reduce time to degree.
- Tuition Plateau Discount at most institutions (can save students \$15,000 or more)
