REVISION:

This amendment is to be a part of Contract MD-17-2486, as has been amended, and is between University of Wisconsin System and U.S. Bank National Association, and amends/clarifies, by mutual agreement by the parties. This Amendment is in regards to the removal of one (1) ATM, details and related sections as below:

ATM Services/Locations

RFB 5.6 states "The Contractor must supply one full service ATM in the Davies Center and one full service ATM in Hilltop Center which are part of a major ATM national network as approved by UWEC and handicapped accessible".

It is the intent of the University and U.S. Bank to maintain ATM Service at the Davies Center only, and conclude the ATM Service at the Hilltop Center on or about May 31, 2025. The ATM at the Hilltop Center shall be removed on or before May 31, 2025.

All other terms and conditions remain unchanged and in effect. This amendment and any/all preceding amendments are to be incorporated by reference of RFB into the final Agreement.
