<u>UW-Madison</u> Approval of Contract: Director of Athletics

Resolution 9118: WHEREAS, the Board of Regents has been presented with a to-be-executed employment agreement ("Contract") between the Board of Regents and the University of Wisconsin system through its duly authorized representative the University of Wisconsin-Madison Chancellor, and Barry L. Alvarez, and WHEREAS, all parties recognize the importance of executing the Contract, which Contract it is anticipated will be subject to renegotiation in the future,

NOW THEREFORE BE IT RESOLVED, that, upon recommendation of the Chancellor of the University of Wisconsin-Madison and the President of the University of Wisconsin System, the Board of Regents does hereby approve said Contract.

<u>UW-Madison</u> Approval of Contract: Head Football Coach

> BE IT RESOLVED FURTHER, that as provided in the Board of Regents' December resolution, in the event either party seeks to amend or request changes to the Contract, including extension(s), or the approval of additional compensation or benefits from whatever source, all terms and provisions of the Contract shall be subject to renegotiation and Board of Regents approval.

<u>UW Colleges and UW-Extension</u> Authorization to Appoint: Interim Chancellor

Resolution 9120: That, upon recommendation of the President of the University of Wisconsin System, Marv Van Kekerix be appointed Interim Chancellor of University of Wisconsin Colleges and University of WisconsinExtension effective January 1, 2006, at an annual salary of \$175,000 and with the other terms, conditions, and benefits as stated in the attached letter of appointment.
