DISCUSSION OF GOALS AND PRIORITIES FOR THE BOARD OF REGENTS PLANNING PROCESS

BACKGROUND

In June 2013, Regent President Falbo announced that the Board of Regents would undertake a planning process. Lead responsibility for identifying goals and priorities was assigned to committee chairs. Overarching goals for the planning process are:

- I. Ensure the Board's work aligns with the strategic goals of the System's universities, colleges, and Extension; these goals include effective resource management, high-quality education, and adequate compensation of faculty and staff.
- II. Structure the administration of the System to most effectively support and strengthen the universities, colleges, and Extension and thereby strengthen the UW's service to students, families, and other stakeholders.
- III. Further develop the Board's and System's role in advocating for System institutions, emphasizing two-way effective communication with campuses, legislators, the Governor, and the citizens of the state.
