BETTER PREPARATION OF GRADUATES: STUDENT ENGAGEMENT THROUGH HIGH-IMPACT PRACTICES

BACKGROUND

Since 2001, UW institutions have been reporting on student engagement activities as a part of their annual accountability reports. Part of the UW System mission is to ensure that students graduate from UW institutions with the integrative learning skills, multicultural competencies, and practical knowledge needed to succeed in a rapidly changing, increasingly global society. How the System creates, maintains, and improves the quality of higher education is of importance to the state as a whole.

DISCUSSION

At its June 2015 meeting, the Board of Regents will hear a presentation on student engagement through high-impact practices. The UW System achieves its mission goal by preparing students through a variety of experiences, both as part of the curriculum and outside the classroom. Recent research provides evidence that a variety of practices that encourage a high level of student engagement are main factors in student success.

In 2014, the Gallup-Purdue University Index Report issued findings from a study of more than 30,000 college graduates across the United States. The study focused on the correlations between college learning opportunities, work, and well-being, and in particular what features of the college experience contributed the most to whether or not graduates had fulfilling jobs and lives. Its findings were that graduates' success was highly dependent on the quality of their college experience overall, connectedness to faculty, and participation in projects and internships as forms of student engagement.

The college experiences that have the greatest impact on student and graduate engagement are what educators call high-impact practices (HIPs). HIPs comprise a range of intellectually engaging and educationally purposeful practices, including:

- first-year seminars and experiences;
- common intellectual experiences;
- learning communities;
- writing-intensive courses;
- collaborative assignments and projects;
- undergraduate research;
- diversity/global learning;

- service and community-based learning;
- internships; and
- capstone courses and projects.

Among the UW institutions' goals is to increase the effective use of HIPS, as part of both the academic and co-curricular programs they offer to students. These effective educational approaches help students achieve those learning outcomes determined as most meaningful by UW institutions and by employers nationwide. They have been shown to raise levels of performance, retention, and success for all students, especially those historically underserved by higher education.

Finally, HIPs also have ramifications on the changing nature of faculty work. They require faculty to increase time commitment, adapt their delivery methods and to employ an increasing variety of instructional digital information technologies.

The purpose of the presentation is to:

- Share research on the efficacy of HIPs in engaging students and increasing student success:
- Explain the key attributes and features of HIPs; and
- Highlight examples from two UW institutions on signature HIPs they offer to students.

Following opening remarks by Interim Senior Vice President David J. Ward, UW-Stevens Point Provost Greg Summers will present information on successful HIPs, such as the university's First-Year Seminar for veterans and undergraduate research in psychology.

UW-Oshkosh Provost Lane Earns will provide information on the university's STEP Program, which features work in the student's chosen degree as a HIP and the University Studies Program (USP), with a focus on a general education activity for second-year students called Quest 3.
