UW-MADISON CONTRACTUAL AGREEMENT WITH EXXONMOBIL RESEARCH AND ENGINEERING CO.

EXECUTIVE SUMMARY

BACKGROUND

UW System Board of Regents policy requires any grant or contract with private profit-making organizations in excess of \$500,000 be presented to the Board for formal approval prior to execution.

REQUESTED ACTION

Adoption of Resolution I.3., approving the contractual agreement between the Board of Regents and ExxonMobil Research and Engineering Company.

DISCUSSION AND RECOMMENDATIONS

The College of Engineering, with assistance from the Office of Industrial Partnerships at the University of Wisconsin-Madison, has negotiated a Sponsored Research Agreement with ExxonMobil Research and Engineering Company. In addition to the Sponsored Research Agreement, the Wisconsin Alumni Research Foundation has negotiated a License Option Agreement with ExxonMobil, to be executed simultaneously, which addresses rights in patentable intellectual property created or developed under the Agreement. In consideration for providing the requested research, ExxonMobil shall pay the University \$650,000. The research project is anticipated to be conducted during the period from March 5, 2015 through March 5, 2017. The research will be conducted in the department of Chemical Engineering under the direction of Dr. George Huber.

The study is titled, "Catalytic Processes for Levoglucosan Conversion into Distillate Range Molecules." The research will study the fundamental catalytic chemistry of the conversion of levoglucosan into distillate range molecules via sorbitol.

INSTRUCTIONAL TECHNOLOGY IN THE UNIVERSITY OF WISCONSIN SYSTEM: HOW FACULTY AND STAFF ARE USING INSTRUCTIONAL TECHNOLOGY TO ENHANCE STUDENT LEARNING

BACKGROUND

Instructional technology has changed the way instruction occurs in the classroom. In the past several decades, faculty and staff have utilized technology to enhance student learning. One of the advantages of being part of a system is the ability for UW institutions to ensure faculty, staff, and students have access to many of the same technology resources. This has been done in many areas of instructional and administrative technology. For instructional technology, the UW System has established a common course management system, presently Desire2Learn (D2L). UW System institutions also established a wide area network to ensure that faculty, staff, and students have access to other educational resources. There are numerous other instructional technology resources that faculty, staff, and students utilize, many of them discipline-specific.

In addition, being part of a system had led to a sharing of expertise and best practices in instructional technology. Faculty and staff from UW institutions often maximize the effective use of instructional technology by working together within departments, across campus, and between campuses.

- Bob Hoar, Chair, Learn@UW Executive Committee and Associate Vice Chancellor for Academic Affairs at UW-LaCrosse, who will discuss how D2L and instructional technology transforms teaching and learning.
- Dawn Drake, Executive Director of Alternative Delivery Systems at UW-Platteville, who will speak on distance education/e-learning.
- Sasi Pillay, Associate Vice President for Learning and Information Technology at UW System Administration, who will speak on digitization, mobility, and other technology advances that can be leveraged in the future.
- The second panel is comprised of two faculty members who will discuss and show how instructional technology has impacted their classes:
 - o Dr. Jamie Schneider, Associate Professor of Chemistry, UW-River Falls.
 - o Dr. Diane Reddy, Professor of Psychology, UW-Milwaukee.
- The third panel is comprised of two provosts who will discuss how they operationalize instructional technology on campus, what kinds of issues they face with instructional technology as provosts, and what instructional technology means to instruction and faculty development:
 - o Bev Kopper, Provost, UW-Whitewater.
 - Sarah Mangelsdorf, UW-Madison (with Steve Cramer, Vice Provost of Teaching and Learning and Bruce Maas, Vice Provost for Information Technology).
