## TASK FORCE ON CAMPUS CLIMATE CO-CHAIRS' REPORT

#### BACKGROUND

Students have raised concerns in Wisconsin and elsewhere related to diversity, inclusion, and campus climate. Within the UW System, a number of steps were taken in 2016 in response to student concerns about climate and incidents of hate or bias on UW campuses. Among these steps was the creation of the Task Force on Campus Climate, announced at the April 2016 Board of Regents meeting following a student presentation regarding climate and diversity-related issues.

#### DISCUSSION

The Task Force on Campus Climate was appointed in October 2016 and charged with reviewing and analyzing current efforts related to campus climate, identifying evidence-based models and approaches, and developing recommendations to aid in the continuous assessment and improvement of campus climate. The task force included members from every UW System institution serving in varying roles -- students, faculty, staff, and administrators. Regents Eve Hall and Ed Manydeeds were appointed co-chairs of the task force.

At the Board of Regents' July 2017 meeting, Regent Hall and Emeritus Regent Manydeeds will provide an overview of the task force's recommendations.

## CAPITAL PROJECTS IN THE UW SYSTEM PROCESS AND PLANNING

#### BACKGROUND

Each state agency and the University of Wisconsin System are required to prepare a capital budget request every two years within the context of a long-range plan. The UW System's process for developing the capital budget recommendation is based on normative higher education planning models. At its July 2017 meeting, the Board of Regents will hear a presentation about how the capital budget is developed each biennium and how specific projects come before the Board of Regents.

#### **DISCUSSION**

The presentation will consist of two parts. First, planning topics will be addressed, to include: supporting documentation, project types and funding, and the status of the 2017-23 six-year capital plan that was reviewed by the Board in August 2016.

Second, the presentation will provide an overview of the strategic issues facing the University of Wisconsin System as the next capital budget biennial planning process begins in September 2017, including incorporation of strategic academic priorities; critical infrastructure, including heating plants; the impact of deferred maintenance funding over time; building systems; and pressures on facilities staff.
