### UW-MADISON CONTRACTUAL AGREEMENT WITH BURNESS COMMUNICATIONS INC.

Vice Chancellor Rob Cramer spoke about the work UW-Madison's Population Health Sciences Institute in the School of Medicine and Public Health is doing with the Robert Wood Johnson Foundation in getting funding for the County Health Rankings Program and

the sub-contractor, Burness Communications Inc. He said the program was created to help counties understand the factors influencing how healthy their residents are and what the trajectory of progress in their health improvement.
