APPROVAL OF THE RECORD OF THE SEPTEMBER 26-27, 2024 MEETING OF THE UW SYSTEM BOARD OF REGENTS

The record of the September 26-27, 2024 meeting of the UW System Board of Regents was approved as distributed.

WELCOME AND INTRODUCTIONS

President Bogost welcomed Regents to the Board's annual retreat and introduced facilitator Steve Kloehn, a partner with Peterson Rudgers Group, LLC.

President Bogost outlined the intended focus of the two-day retreat, which was to review and support the goals of the Universities of Wisconsin and the fiduciary duties of the Board, as well as to further build relationships between Board members.

Mr. Kloehn led the Board in a discussion on higher education board service, inviting Regents to introduce themselves and share their reasons for serving and the impact higher education has had on their own lives.

PRESENTATION AND DISCUSSION: "PRINCIPLES OF TRUSTEESHIP"

Mr. Kloehn shared a presentation entitled, "The Role of a Regent," which covered principles and best practices for effective board governance, drawing on the "Principles of Trusteeship" published by the Association of Governing Boards of Universities and Colleges (AGB).

The Board separated into small groups to discuss various governance topics, including effective meeting agendas, the respective roles and responsibilities of the board and of management, and how to be effective ambassadors for the universities and higher education, before reconvening to discuss as a full group.

Regents noted the importance of having mindful meeting agendas that include presentations focused at the strategic rather than management level, forward-looking discussions on emerging or potential issues or opportunities, as well as continuing education on higher education topics and areas of interest.

Regents also highlighted the importance of regional engagement in building partnerships and advocating on behalf of the universities.

Following lunch the Regents again separated into small groups to continue discussion on best practices in governance, including onboarding of new Board members and cultivating conditions for substantive and open dialogue during meetings. The Board then reconvened for a full group discussion.

Regents discussed potential changes to the onboarding process, including further developing the peer mentor program and adding more emphasis during onboarding at the committee level with the involvement of the committee chair and staff liaison.

Regents agreed on the importance of holding robust, open discussions at committee and full Board meetings, and of encouraging new members to contribute comments and ask questions.

PRESENTATION AND DISCUSSION: "PUBLIC ENGAGEMENT"

Mr. Kloehn presented on principles and best practices related to public engagement for board members.
