Appointment of Dr. Manohar Singh as Chancellor of UW-Oshkosh

Resolution 12319 That, upon the recommendation of the Special Regent Committee for the UW-Oshkosh Chancellor Search and the President of the UW System, Manohar Singh be appointed Chancellor of the University of Wisconsin-Oshkosh, effective July 1, 2025, at an annual salary of \$300,000.
