The Board of Regents of the University of Wisconsin System will hold a public hearing on permanent rules to amend Chapters UWS 4, 7, 11, Wis. Admin. Admin. Code, relating to disciplinary proceedings for students in instances of sexual harassment, sexual assault, dating violence, domestic violence and stalking.
