#### Overview

The University of Wisconsin System currently supports a common, and centrally hosted, Learning Management System (LMS), utilizing the Desire2Learn (D2L) application platform. The existing contract with D2L ends in July 2013. With the fast changing LMS landscape, emerging technologies, and an agreement with the Department of Administration (DOA) to study the LMS market prior to a contract renewal, the Learn@UW Executive Committee has formed the LMS Exploratory Task Force to provide guidance. This initial step is taken to address the future direction of LMS use for UWS.

### **Project Deliverables**

The Task Force will deliver a written report on the findings and recommendations to the Learn@UW Executive Committee and the UW System CIO by July 1, 2011.

### Project Scope

It is the goal of the Task Force to review the current state of UW System's use of the current LMS, understand the extent to which the current platform meets existing and emerging needs, assess the existing LMS market space and other strategies to meet the needs of online learners, and be mindful of the impact of change on campus resources.

- Study the status of the current LMS (D2L) at UW campuses from the faculty, student, and academic program's perspectives. Assess any current unmet needs and requirements and identify those needs most effectively addressed via the LMS product.
- Scan the current LMS environment and ascertain how D2L's current offerings and product development roadmap compare to other vendors.

- Scan the emerging technology trends and provide recommendations about the needs that should be addressed by the LMS or LMS related strategies to meet the needs of online learning in the next five years.
- Make recommendations to the Learn@UW Executive Committee and the UW System CIO on the next steps in the LMS direction.

The outcome of this task force will align with the UW System's Common Systems roadmap and recommendations from the eLearning Workgroup on Lifecycle Planning.

### Assumptions

In keeping with the mission of the University of Wisconsin, it is necessary to examine the use of instructional technologies, current trends in Higher Education, and continue the tradition of providing a learning environment that employs high quality instructional systems. It is our responsibility to seek opportunities to improve available services to meet the present and future needs of UW System institutions.

There is sufficient leadership within the Stakeholders to provide support to implement recommendations from the task force concerning the use of an LMS.

### Budget

There is "limited funding" available to support the efforts of the task force, e.g. travel to learn from other institutions, employ limited consultative services, etc. All requests for funding need the approval of Ed Meachen, Task Force Co-sponsor.
